1.0. Approval of September 23 Minutes

Minutes of the September meeting were approved.

2.0. Key Stakeholder Committee

CSWB co-chairs and staff presented recommendations for initial invitees to the Key Stakeholder Committee which included:

- Medical Officer of Health, Huron Perth Public Health (HPPH)
- President and CEO, Huron Perth Healthcare Alliance (HPHA)
- Executive Director, Choices for Change
- Executive Member, Huron Perth and Area Ontario Health Team (HPA-OHT)
- Executive Director, United Way Perth-Huron (UWPH)
- Executive Director, Huron-Perth Children's Aid Society (CAS)
- Co-Chair, Stop VAW Coordinating Committee of Perth

These positions were chosen for the following reasons:

- Well-connected to represent their sector
- Involved in other collaborative committees or initiatives
- Have the potential to provide expertise on several CSWB priority areas
- Have decision-making authority for their organizations and committees

The suggested invitation process would consist of a written letter from the CSWB co-chairs with some background information and an invitation to meet in person to review the Terms of Reference and discuss expectations and responsibilities.

Discussion:

It was agreed that the list was a good start and that it made sense to include people whose positions span multiple CSWB priorities. Initially the list was provided with people's names, but the group suggested we focus on the position rather than the person to allow more flexibility for the organizations or initiatives when deciding who would represent them. It was agreed, however, that KSC members should have decision-making authority — either through their position or by delegation.

There was also a request to make sure long-term care was represented in the healthcare sector, in addition to population health (HPPH) and primary health (HPHA). Several LTC homes are members of the OHT-HPA and that representative could provide that specific perspective. If not, an executive director from a LTC facility could be invited.

The group agreed with the invitation process and there was consensus to move forward.
